2. Review of RPPPO activities

**Asia & Pacific
Plant Protection
Commission**

○ **APPPC – 25 countries**

- ISPM implementation – ISPMs 6, 12, 31 and 15
- Strengthening information exchange – quarterly monitoring of country pages and summaries shared with all APPPC countries
- Developing of capacities in pest surveillance and pest management
- 29th session of the APPPC - Sept. 2015 in Indonesia
- Adopted a work plan for 2016/2017 including 6-year plan for surveillance
- Supporting ePhyto IPPC Hub pilot project – involvement of 6 countries
- Developing RSPM on HWT of mango fruit for fruit flies
- Outbreaks - Yellow-spined bamboo locust
- Pest incursions - Mango cecid fly, mango pulp weevil



2. Review of RPPPO activities

○ **CAN – 4 countries**

- Promoting implementation of ISPMs
 - Pest status (ISPM 8), PRA (ISPMs 2 and 11)
 - Phytosanitary measures applied only to regulated pests
- Regional contingency planning to prevent introduction of Huanglongbing and *Fusarium oxysporum* f. sp. *cubense* raza 4 tropical
- Updating phytosanitary requirements for 31 plant products
- Building their website
- Harmonizing procedures for registration and control of pesticides

2. Review of RPPPO activities



○ **COSAVE – 6 countries**

- Several resolutions – harmonized import requirements for alfalfa seed
- Regional plans of action for containment, control, surveillance and contingency planning for several pests
- Strategic guidelines 2014-2015 – cooperation, improving capacity, implementation
- Work plan of the COSAVE Technical Groups – harmonization of phytosanitary requirements, evaluation revision of ISPM 6, assessing pilot for ePhyto
- STDF project approved – strengthening the region on implementation of phytosanitary measures and market access

2. Review of RPPPO activities



○ **EPPO – 50 countries**

- New pests recommended for regulation, updating A1 and A2 lists
- New Regional Standards adopted – diagnostic protocols, phytosanitary measures and procedures, national regulatory control systems
- Priorities set for PRA, and a survey of members' use of PRA schemes
- Study conducted on wood commodities - chips etc.
- Reviewed regulation of biocontrol agents, learning from other regions
- Extended the Euphresco network of phytosanitary research funders and managers - welcoming some partners beyond the EPPO region
- Co-ordination of regional input to IPPC/CPM activities

2. Review of RPPPO activities

○ **IAPSC – 54 countries**

- Strategic and Implementation plan 2014-2023 endorsed by the Conference of the Specialized Technical Committee (meeting of Ministers of Agriculture, Rural Development, Water and Environment) Oct. 2015
 - NPPO structures amended
 - ISPMs implemented and coordinated
 - National plant quarantine services operational according to standards
- List of emerging and re-emerging pests in Africa
 - Fruit flies – trade
 - Cassava mosaic and cassava brown streak
 - Banana wilt and banana bunchy top
 - *Tuta absoluta*

2. Review of RPPPO activities



○ NEPPO – 12 countries

- Participated in technical workshop on *Fusarium* wilt disease of Banana (Dec. 2014)
- Established Arabic Language review group for standards
- Established a core Pest Risk Analysis group
- Collects plant protection information and share with member countries via their website
- Emerging pests of concern
 - *Xylella fastidiosa* in Olive
 - Red palm weevil
 - Fruit flies – *B. zonata* and *B. dorsalis*
 - *Tuta absoluta*
 - *Drosophila suzukii*
 - Huanglongbing

2. Review of RPPPO activities



○ **NAPPO – 3 countries**

- Relocation of the NAPPO Secretariat
- Revision and update of several RSPMs – 7, 12, 18, 26, 29 and 33
- Symposium on Innovations in Pest Risk Management (RSPM 40) – all presentations on the website – www.NAPPO.org
- Workshops and Meetings
 - 2015 - Implementation of RSPM 12 and RSPM 33 and needs assessment for regulatory support of the seed industry
 - 2016 - ISPM 15 implementation workshop with focus on the “Americas”
 - 2017 – Risk-Based Sampling International Meeting
- **40th Annual Meeting in Montreal, Quebec, Canada – please join us!**

2. Review of RPPPO activities



○ OIRSA – 9 countries

- Workshop for the development of a regional list of quarantine pests – Dec. 2015
- Regional workshop for development of a continental action plan for *Fusarium oxysporum* f sp. *cubense* TR4 (Panama disease) – Mar. 2015
- Assistance to eradication of SA cucurbit fly – *A. grandis* in Panamá
- Biological control strategies for PHM (*Maconellicoccus hirsutus*)
- PRA for Kudzu bug (*Megacopta cribaria*)
- National phytosanitary programs in support of NPPOs
 - Pest surveillance, pest diagnostics

2. Review of RPPPO activities

○ **PPPO – 26 members**

- Collaboration with APPPC on workshops on surveillance and ePhyto
- Biosecurity legislation review for Fiji and Cook Islands
- Participation in US – Plant Health Systems Analysis course – 7 participants
- PPPO mailing list for information exchange
- Technical assistance – Biosecurity “Help desk”
- New PPPO logo
- Delimiting surveys for Yellow crazy ants (*Anoplolepis gracilipes*) in Tuvalu and Nauru
- Work with Cook Islands NPPOS to eradicate oriental fruit fly (*B dorsalis*) from the island

7. RPPO Roles and Functions; the 27th TC of RPPOs ..

- Reviewed the RPPO Roles and Functions document presented and approved in 2005 by ICPM
- Agreed that some roles should be **preserved/continued** – standard setting
- Agreed that **new areas of cooperation** – enhancement study implementation plan, International Year of Plant Health – **should be pursued**

7. RPPO Roles and Functions; the 27th TC of RPPOs ..

- **Requests** that IPPC Secretariat, SPG, CDC and CPM subsidiary bodies continue to collaborate with RPPOs
- Suggests using the **Technical Consultation of RPPOs** as a mechanism to facilitate this collaboration
- Asks CPM to **note** ... the revised R&F document will be submitted for **adoption at CPM 12**
