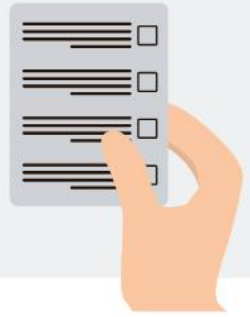

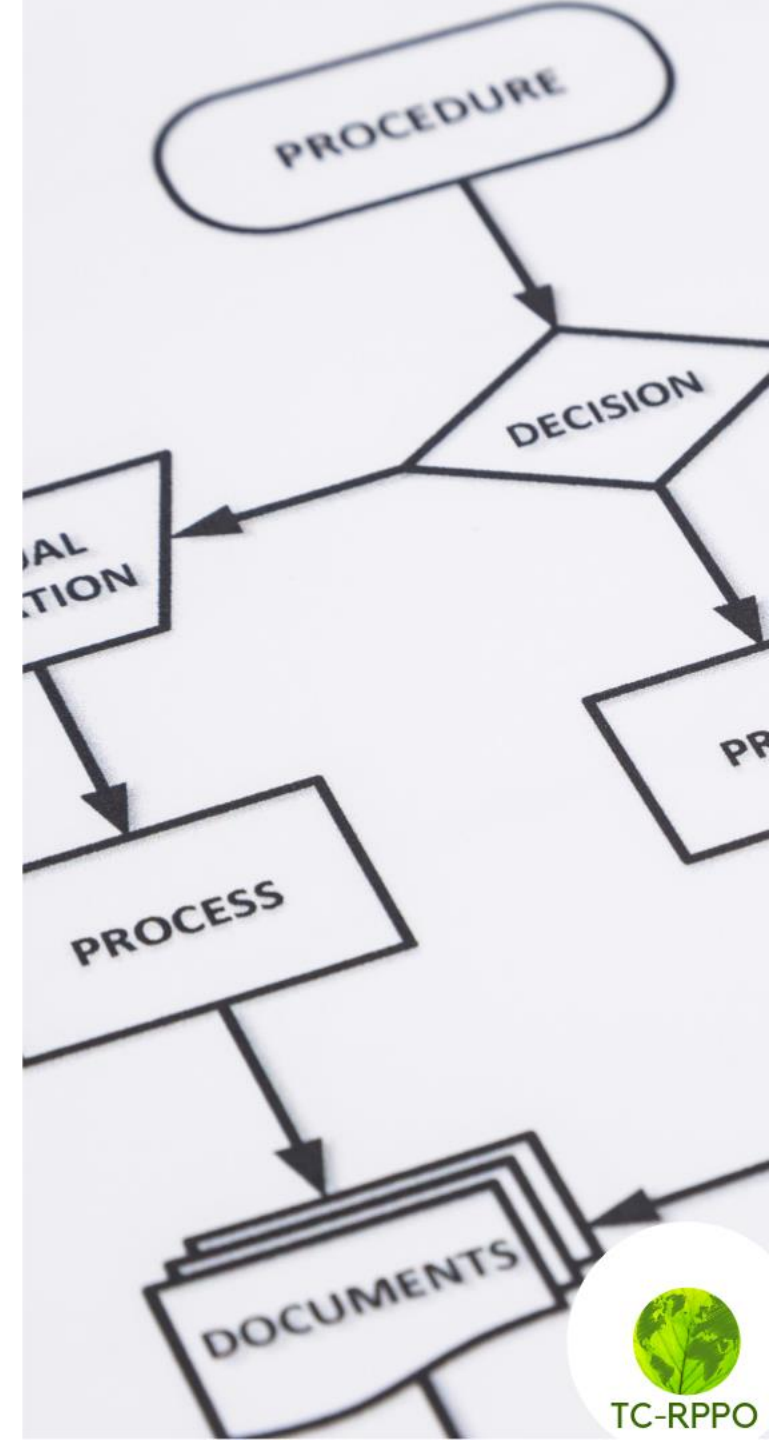
## New TC-RPPO Terms of Reference and Rules of Procedure

**TC-RPPO agreed a draft document**

CURRENT STATUS: **STILL ANALYZING THE DRAFT**

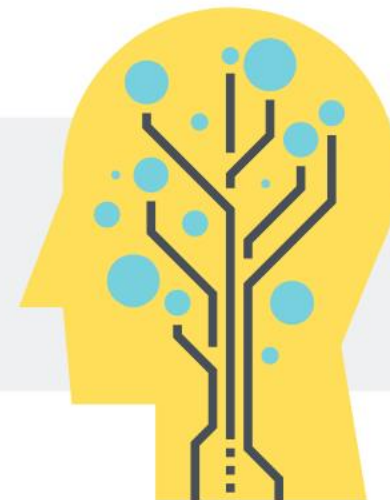
The TC-RPPO advanced considerably to agree on a draft document of ToRs and RoPs to achieve a consistent work procedure and **improve coordination in tackling the global and regional common problems** and in providing active support to the CPM and NPPOs.

Once the TC-RPPO review the inputs from FAO and IPPC Secretariat, is expected to present the document of ToRs and RoPs for the CPM - 15 in 2020.

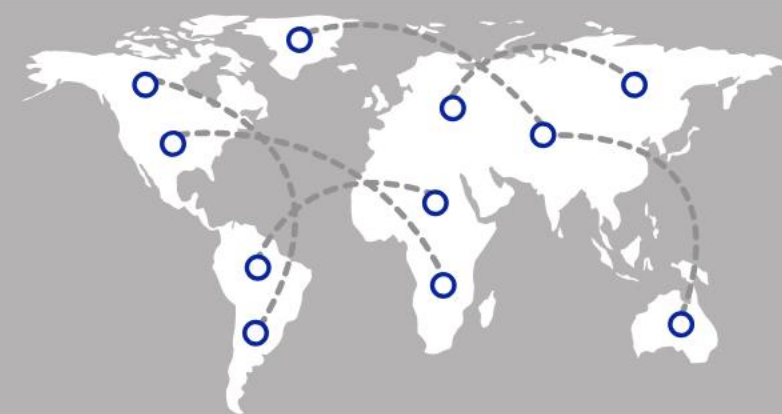




## 2 Work on the concept of an emerging pest

TC-RPPO recommended: to perform training sessions for specific items as suggested by the Task Force on how to prepare a submission for the Call for Topics and to include discussions on the emerging pests, as appropriate.
