[26] INTRODUCTION

[27] Scope

[28] This standard provides a framework that enables national plant protection organizations (NPPOs) to authorize private entities to perform specific phytosanitary actions associated with import, domestic and export system on behalf of the NPPO. Elements of this standard may also apply when authorizing public entities.

[29] This standard does not cover the issuance of phytosanitary certificates; these are issued by authorized public officers only (Article V.2(a) of the IPPC).
