



## IPPC CONTRACTING PARTIES PLEDGED CONTRIBUTIONS AT CPM-20

The following IPPC Contracting parties pledged the following contributions at CPM-20 and in 2026:

### **Financial contributions:**

#### **Argentina – USD 21,800**

- To the ePhyto Multi-Donor Trust Fund (GCP/GLO/1304/MUL).

The official letter from Argentina was received on March 5<sup>th</sup>. Funding was also announced on March 11<sup>th</sup> at CPM-20.

#### **Australia – AUD \$300,000 (USD 213,000)**

- To the IPPC Multi-Donor Trust Fund (MTF/GLO/122/MUL):
  - o AUD \$100,000 to support CPM approved Standards Committee and Implementation Committee workplan activities. This funding is closely aligned with CPM workplan priorities, including accelerating the development of guidance material following the adoption of new standards.
  - o AUD \$100,000 to support the development of the new Strategic Framework, including travel and delegate participation for eligible countries during the consultation process, with a preference for representatives from the Pacific region.
- To the ePhyto Multi-Donor Trust Fund (GCP/GLO/1304/MUL):
  - o AUD \$100,000 comprising Australia's expected annual voluntary contribution to the ePhyto Solution for 2027 and funds supporting the continued operation and long-term maintenance of the program.

The official letter from Australia was received on February 27<sup>th</sup>. Funding was also announced on March 10<sup>th</sup> at CPM-20.

#### **Canada – CAD \$410,000 (USD 302,000)**

- To the IPPC Multi-Donor Trust Fund (MTF/GLO/122/MUL):
  - o CAD \$140,000 Funding of a Sea Containers Workshop in 2026.
  - o CAD \$120,000 Funding of an Expert Drafting Group tasked with the revision of International Standard for Phytosanitary Measures (ISPM) 12: Phytosanitary Certificates.
- To the ePhyto Multi-Donor Trust Fund (GCP/GLO/1304/MUL):
  - o CAD \$150,000 Funding for the IPPC ePhyto Solution.

The official letter from Canada was received on February 13<sup>th</sup>, and IPPC Secretariat replied by accepting the funding on February 25<sup>th</sup>. Funding was also announced on March 10<sup>th</sup> at CPM-20.

**Ireland – EUR 85,000 (USD 99,000) – already received**

- To the IPPC Multi-Donor Trust Fund (MTF/GLO/122/MUL): EUR 50,000
  - o Funding for the IPPC Pest Outbreak Alert and Response Systems (POARS).
- To the ePhyto Multi-Donor Trust Fund (GCP/GLO/1304/MUL): EUR 35,000

IPPC Secretariat accepted the funding on January 6<sup>th</sup>. Funding was also announced on March 10<sup>th</sup> at CPM-20.

**Netherlands, Kingdom of the – EUR 50,000 (USD 58,000) – already received**

- To the IPPC Multi-Donor Trust Fund (MTF/GLO/122/MUL): EUR 30,000
  - o Funding to support the project “Safe Provision of Food and Other Humanitarian Aid” of the IPPC.
- To the ePhyto Multi-Donor Trust Fund (GCP/GLO/1304/MUL): EUR 20,000

The official letter from The Kingdom of the Netherlands was received on November 5<sup>th</sup>, 2025, and IPPC Secretariat replied by accepting the funding on December 10<sup>th</sup>. Funding was also announced on March 10<sup>th</sup> at CPM-20.

**Republic of Korea – USD 189,800**

- To the IPPC Multi-Donor Trust Fund (MTF/GLO/122/MUL).

IPPC Secretariat accepted the funding on February 24<sup>th</sup>. The funding was pledged on March 10<sup>th</sup> during the CPM session.
