Asia and Pacific Plant Protection Agreement and the commission (APPPC)

❖ Plant Protection Agreement-2 July 1956

❖ Amendments:

➤ 1967 (in force-16 Aug. 1969)

➤ 1978 (in force-16 Feb. 1983)

➤ 1983 (A) (in force-23 May 1990)

➤ 1983 (B) (in force-4 Sept. financial obligations)

➤ 1999 (A+B) (pending)

(Two sets of the amendments to the Agreement in line with IPPC/1997 and SPS)

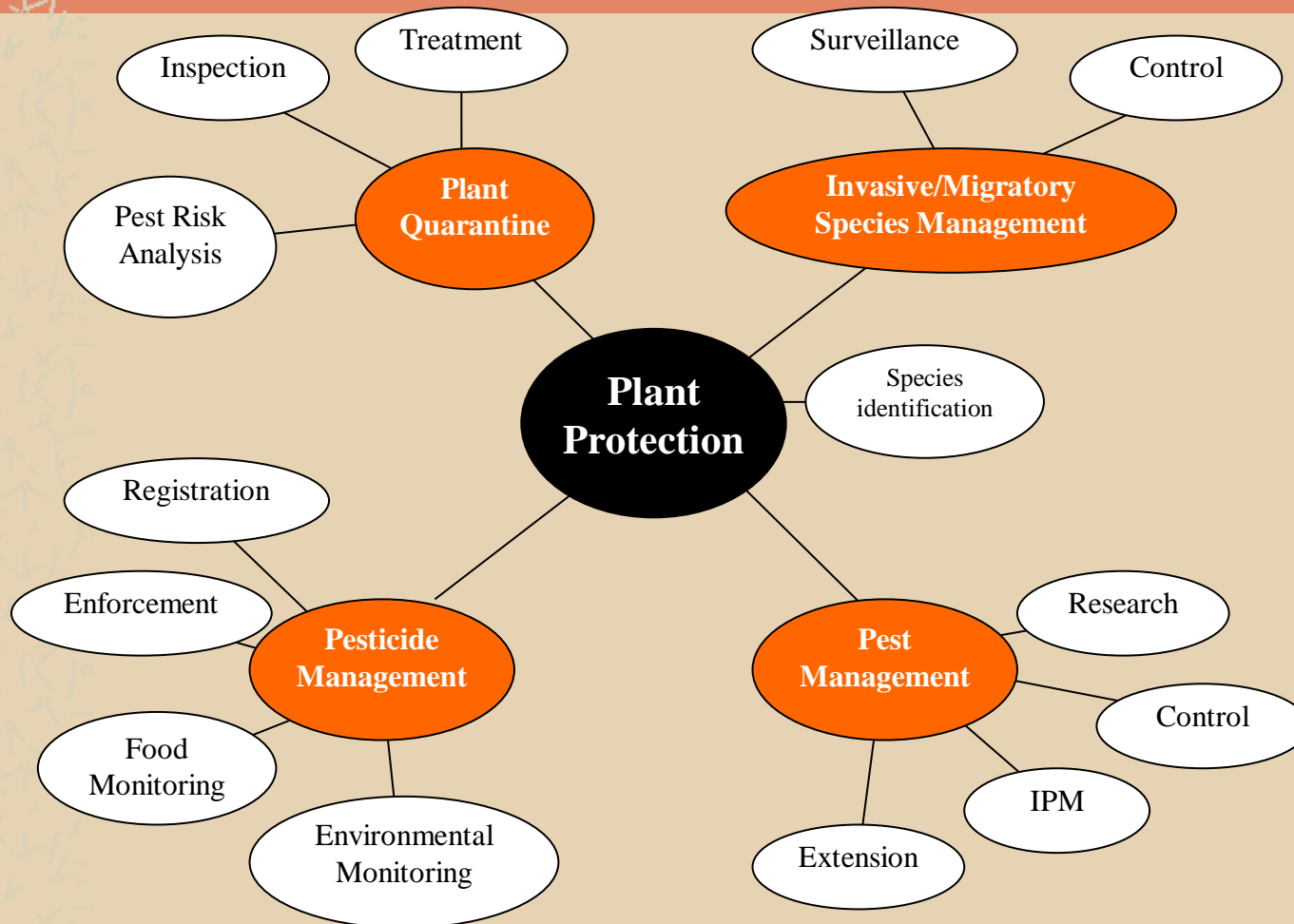

Plant Protection Functions



Regional plant protection organizations - RPPOs

RPPOs develop regional phytosanitary standards

- RPPOs identify regional needs for standards
- Standards are developed and implemented regionally and often become the basis for international standards (ISPMs)

- ✿ NAPPO: North American Plant Protection Organization
- ✿ OIRSA: Organismo Internacional Regional de Sanidad Agropecuaria
- ✿ PPPO: Pacific Plant Protection Organization
- ✿ NEPPO: Near East Plant Protection Organization
