## NPPO objectives

The objectives of an NPPO within the context of national development plans may be translated into three broad areas of responsibility:

- to protect plant resources (including cultivated, wild and aquatic plants) through implementation of appropriate phytosanitary measures;
- to support national food security and a healthy environment through effective pest exclusion procedures;
- facilitate market access and safe international trade in agricultural commodities by establishing effective phytosanitary certification systems and procedures.

The fulfilment of these objectives requires a well-organized, fully functional NPPO with appropriate national, regional and international networks.

## Structure of the NPPO

Having a robust structure of the NPPO that would cope with all the IPPC responsibilities over time is essential in keeping an appropriate level of phytosanitary protection in a country.

The Chapter 6 (page 19) of in a new manual that became recently available: <u>"Establishing a National Plant Protection Organization"</u> describes in more detail principles regarding the required infrastructure and organizational structure of an NPPO that should be followed while establishing such an organization.

You can find there (page 21) an Organogram of the functions that should be fulfilled by an NPPO (an example for an autonomous NPPO) where the NPPO is organized by branches (technical management, pest diagnostics and operational services) required to perform the basic functions (national programmes) in PRA, import verification, export certification, pest surveillance, regionalization (including containment, control, eradication and freedom from pests) and phytosanitary training and promotion.

You can also familiarize yourself in the manual with 5 models of an NPPO illustrating institutional arrangements which you might find helpful:

- Model 1: Plant protection and quarantine sections or departments of the Ministry of Agriculture functioning as the NPPO;
- Model 2: The Ministry of Agriculture as the designated NPPO;
- Model 3: NPPO with some key functions delegated to third parties;
- Model 4: Semi-autonomous or autonomous organization;
- Model 5: Integrated institution.

The NPPO institutional structure varies from country to country and is influenced by policy and legal considerations, availability of resources and national competencies. More recently, models with greater autonomy or an integrated approach (associating plant health competencies, as well as animal health and food security ones) have been adopted, as they are more appropriate to fulfilling broader functions.

All models have strengths and weaknesses and only after a careful analysis a country should take decision about the most appropriate model for its use.
