New NRO statistics became available

The Secretariat has prepared 6 new types of statistics for NRO showing comprehensive summaries and graphics based on reports uploaded by countries on the IPP. In total they consist of 17 graphs and 27 tables which become automatically updated while more reports are added to the IPP. In particular, you can find the following information in the statistics:

- 1. Status of IPPC Contacts Points:
 - Changes among IPPC Contact Points;
 - Activity of IPPC Contact Points and IPP Editors on the IPPC.
- 2. Summary statistics for National Reporting Obligations: NROs since 2005 (2005-2017).
- **3.** Summary statistics for National Reporting Obligations: NROs in a particular year (e.g. 2016).
- 4. NROs: Submission trends (comparison between 2015 and 2016).
- 5. Detailed statistics for each NRO.

The data is being used for the analysis of trends and developments in NROs and are indicators of the effectiveness of the NRO Programme.

All NRO statistics are available on the IPP for all readers (there is no need to log in to the IPP to see them).

Automated IPP NRO reminders system – general overview

NROAG established in July 2014 the development of an automated IPP NRO reminders system as one of the short-term goals which was included in the NRO Work Plan. As requested the Secretariat developed the system which became operational in July 2016.

NRO automatic reminders have been scheduled to be sent out throughout the year to the email accounts of all Official Contact Points. The following frequency for all Public NROs which are supposed to be reported through the International Phytosanitary Portal (IPP), and for dysfunctional links and IPP editors was set:

NRO category	Frequency	Month
Contact Point (contact details)	Every 3 months	January, April, July, October
Pest reporting & Emergency action	Every 6 months	February, August
Description of the NPPO Entry Points List of Regulated Pests Legislation: Phytosanitary Requirements/Restrictions/ Prohibitions	Every 12 months	November
Information about FILEs or URLs	Every 3 months	March, June, September, December
Information about IPP Country Editors	Every 12 months	May

In effect, Official Contact Points receive one automatic reminder every month. For NRO categories which are strictly bilateral (e.g. Rationale for phytosanitary requirements or Non-compliance) no automatic reminder is sent out.

The recipients are asked to provide feedback on the system by sending it to: IPPC-IT@fao.org . The feedback is being analyzed successively in order to readjust the system according to the users' needs.
