WTO SPS Agreement

Right to protect human, animal, plant life or health



Obligation to avoid unnecessary and unjustified barriers to trade





Development of SPS measures

- SPS measures should inter alia be:
 - non-discriminatory
 - transparent
 - not more trade-restrictive than necessary
 - science-based (risk assessment)
- Harmonization international standards















Implementation of SPS measures Annex C

Avoid unnecessary trade disruption and costs when performing <u>control, inspection and approval procedures</u>

- no undue delays;
- information requirements limited to what is necessary;
- non-discriminatory fees;
- non-discrimination in siting of facilities/selection of samples;
- procedure to review complaints, take corrective action, etc.

SPS Annex C closely linked to TFA







TFA Final Provisions: paragraph 6




