1. Decisions of the CPM12 on the IC

1.1 Terms of Reference and Rules of Procedure of the Implementation and Capacity Development Committee (IC)

- [1] The IPPC Secretariat presented TOR and ROP of the IC with the amendments suggested by the FAO LEGA officer. The amendments were mainly of an editorial character and aimed to align the TOR and ROP with the FAO good practices.
- [2] The CDC and the CPM Bureau representative thought that amending of the document approved by the CPM would cause a new round of discussions that is not advisable at this stage. The suggestion was made to keep the TOR and ROP of the IC as adopted by the CPM12. The CDC Chair advised that the IC might take those amendments into account at the later stages once the IC is established and operating, as there is a provision for amendment when necessary.
- [3] The CDC:
 - (1) *Agreed* not to make any changes to the Terms of Reference and Rules of Procedure of the Implementation and Capacity Development Committee (IC).
 - (2) *Noted* the TOR and ROP of the IC as adopted by the CPM12.

1.2 Discussion how National Reporting Obligations Advisory Group (NROAG), Triennial Review Group (TRG) and Subsidiary Body on Dispute Settlement (SBDS) will be integrated within the IC - recommendations to the CPM Bureau

1.2.1 SBDS

- [4] The CDC examined whether the roles and functions of sub-groups should be absorbed by the IC or whether the sub-groups be established under the IC on ad hoc basis with appropriate TOR and ROP for each. The sub-groups to be overseen by the IC were then compared to the structure of sub-groups that exist under the Standards Committee (SC). It was also discussed whether the appointment of stewards as it works within the SC would be advisable for the coordinating work of a specific area/topic and making recommendations for decision by the IC.
- [5] The Secretariat thought that the main considerations should be given to principal functions of the SBDS to be absorbed by the IC. The CDC members highlighted that a special emphasis should be given to dispute avoidance as an effective implementation outcome, and then the principal issue to decide is how the IC operates when a dispute comes to the committee.
- [6] The CDC suggested the following options for the SBDS integration into the IC:
 - (1) *Take* on board current structure of the SBDS with ability to establish ad-hoc groups to address disputes with financial resources.
 - (2) *Focus* on dispute avoidance with possibility for the IC to provide rapid recommendations for dispute settlement.
 - (3) *Disputes go* to the WTO with the IPPC as a service provider for expert advice.
 - (4) Any option selected by the IC or combination of options should get the approval of CPM.

1.2.2. IRSS TRG

[7] It was agreed by the CDC that the TRG was not necessary to be integrated in the IC, as it was composed of existing subsidiary bodies chairs. With the new structure of the IC, the CDC considered the TRG as obsolete since the IC can now provide the necessary inputs directly to the IRSS. It was suggested that issues of the IRSS are kept as a standing item on the IC agenda. That would cover review of IRSS products and oversight of the work plan.

[8] The CDC suggested:

- (1) TRG to be *dissolved* and not to be integrated in the IC.
- (2) *Including* the IRSS oversight as a standing item on the IC agenda with the coverage of review of IRSS products and oversight of the work plan.

1.2.3. NROAG

- [9] The CDC recalled task of the NROAG. It was highlighted that the NROAG mainly works virtually and has not been very active.
- [10] The CDC concluded that the membership to the NROAG is already similar to the IC structure and that additional membership is not necessary.
- [11] The CDC suggested that the first activity of the IC would be to review the IPPC work programme of the NRO. The IPPC Secretariat should provide the clear outline of products and timelines that requires input of the IC. Then the IC would consider the workload over a year to determine if they should establish a task force or other modality for specific oversight. The NRO should be a standing item on the agenda of the IC.
- [12] The CDC proposed:
 - (1) To defer the discussion on NROAG to the IC.
 - (2) IC *reviewing* the work programme of NRO and obtaining from the IPPC Secretariat a clear outline of products and timelines that requires input of the IC.
 - (3) The IC to *determine* whether to establish a task force or other modality for specific oversight of NROs based on the anticipated workload.

1.3 Joint SC/IC call for topics for standards and issues for implementation

1.3.1 Justification and mechanism for the call including criteria for topics

- [13] The CDC discussed the background and issue and recommended.
- [14] General considerations for the Call:
 - (1) Propose to change the title of the call to 'A call for phytosanitary issues'.
 - (2) Current ISPM call for topics template to be adapted to include implementation criteria.
 - (3) A joint task force (JTF) between the IC and SC to be established with the responsibility to assess submissions received from the call and develop recommendations.
 - (4) Recommendations to be submitted to the SC and IC concurrently.
 - (5) SC and IC to provide conclusions on the recommendations to the task force.
 - (6) The task force meets again to review SC and IC conclusions before final recommendations are sent to the SPG.
 - (7) The final recommendations of the task force assessment is made available to contracting parties on the IPP.
 - (8) SPG reviews and endorses the final recommendations of the task force.
 - (9) Based on the first call and the assessment, lessons learned are produced.
 - (10) Modifications are made to related SC procedures regarding the selection and prioritization of topics.

1.3.2 Call

- [15] A call can be made for new issues, selected topics on the work plan and adopted standards:
 - (1) Propose to extend the period between calls to every three years on any of these issues or combination thereof.
 - (2) Ask contracting parties to specify what type of resource (ISPM, implementation resource or other) they are requesting.
 - (3) Propose for the call to be initiated in January, instead of current practice, to allow for appropriate engagement of the joint task force and SC/IC according to the proposed work flow process.

1.3.3 Analysis of submissions received

- [16] The Framework for Standards and Implementation is used for the analysis of submissions received.
- [17] As appropriate, the IRSS may be called upon to investigate an issue further, field missions for validation of feasibility or other analytical processes might be employed.
- [18] Considerations are given to stakeholders affected by an issue (wide reaching) and to global applicability.
- [19] An appropriate format is developed to report the assessment outcomes of issues.

1.3.4 Follow-up actions

- [20] After a priority is set by CPM, then the IC must plan to undertake the appropriate actions to address an issue (e.g. development of guidelines or a capacity development workshop).
- [21] The development of guidelines or organization of work to address the issue must be planned to include allocation of resources.
- [22] CPM discussion of issues provides transparency to the process of prioritization for development of ISPMs or implementation resources.
- [23] To look at the implications of this new process, cost to the IPPC Secretariat and workload of the IC/SC.
- [24] In determining follow up actions, the following was highlighted for consideration by the IC:
 - (1) General understanding that topics/issues can only be developed if resources are available.
 - (2) CPM is to decide on the prioritization of topics for standards and consider implementation issues.
 - (3) The IC will develop a specific list and types of resources to address those implementation issues considered feasible by the CPM.
 - (4) The work plan of the IC is not only guided by this work but by other priorities identified.
- [25] The CDC suggested Work flow for the Joint call:



1.4 Operation framework for the IC based on its scope from the TOR

- [26] Based on the IRSS review of contracting party implementation, PCE applications outcomes and other assessment reporting, the IC will identify and review baseline capacity and capability required by contracting parties to implement the Convention (every three years based on IRSS analysis to provide the primary baseline information, incorporating the M&E outcomes).
- [27] The outcomes of reviewing baseline capacity and capability, the IC recommendations and the call outcomes and follow-up actions will be used to develop and facilitate the delivery of an implementation support programme to enable contracting parties to meet and enhance the baseline capacity and capability.
- [28] Under the IPPC/IRSS Monitoring and Evaluation (M&E) framework, the impact of implementation will be monitored and evaluated to report on progress indicating the State of Plant Protection in the World.
- [29] The IPPC Resource Mobilization Task Force (RMTF) will meet with the IC to inform on the situation of potential donors to secure sustainable funding for its activities. This will coincide with the second IC meeting each year.
- [30] To oversee dispute avoidance and settlement process the IC will decide whether:
 - (1) To take on board current structure of the SBDS with ability to establish ad-hoc groups to address disputes with financial resources;
 - (2) Focus on dispute avoidance with possibility for the IC to provide rapid recommendations for dispute settlement;
 - (3) Disputes go to the WTO with IPPC as a service provider for expert advice;
 - (4) Any option selected by the IC or combination of options should get the approval of CPM.
- [31] To oversee national reporting obligation processes the IC will review the work programme of NRO and obtain a clear outline of products and timelines that requires input of the IC from the IPPC Secretariat. Then the IC will determine whether to establish a task force or any other modality for specific oversight of NROs based on the anticipated workload.
- [32] The IC will meet twice a year (mid-year hosted by a contracting party and end-year in Rome).
- [33] There will be a joint task force formed with the SC to assess calls for issues.

- [34] The IC will absorb the NRO functions as part of their regular agenda.
- [35] The IC will form an ad-hoc SBDS group when necessary and include dispute avoidance as part of their regular agenda.
- [36] The IC will absorb the TRG functions the IRSS will be included as part of their regular agenda.

1.5 Priority tasks for the IC – contribution of the CDC based on the discussions of the first three days of the CDC meeting

[37] The CDC identified lessons learnt and priority tasks that might be useful for the IC to consider:
