Revision – changes after 1st consultation in yellow

"survey (of pests)":

"An official procedure conducted over a defined period of time to determine the presence or absence of pests in an area, or the boundaries or characteristics of a pest population or to determine which species are present in an area, place of production or production site"

• Although place of production and production site are smaller entities within an "area", it is important to add "place of production or production site" to clarify that surveys can also be conducted at those smaller, specific levels, as they can be used to establish pest free places of production or pest free production sites (as per ISPM 10), in alignment with newly revised ISPM 6 (Surveillance)





Revisions (no change)

"growing period (of a plant species)":

"Time pPeriod of active growth during a growing season when a plant species actively grows in an area, place of production or production site"

- "Grows" does not merely mean increasing size, but includes the notion of development.
- The addition of "in an area, place of production or production site" is necessary to convey the idea that the growing period depends on the local growing conditions (e.g. the growing period of a plant can be different under field conditions and in a greenhouse). This is important for countries when setting their phytosanitary import requirements or undertaking phytosanitary actions.





Deletions – recommendations unchanged after 1st consultation

"growing season":

"Period or periods of the year when **plants** actively grow in an **area**, **place of production** or **production site**"

"confinement (of a regulated article)":

"Application of phytosanitary measures to a regulated article to prevent the escape of pests"

"mark":

"An **official** stamp or brand, internationally recognized, applied to a **regulated article** to attest its phytosanitary status"
