### I. Background

At CPM-9 (2014), for the first time, participants were invited to share their successes and 1. challenges in implementing the IPPC, ISPMs and CPM recommendations. These presentations were favorably received and became a standing item on the CPM agenda.

#### II. **Submissions**

IPPC contracting parties, RPPOs and CPM observers have the opportunity to share their success 2. stories or to propose solutions to their challenges on issues related to the implementation of the IPPC, ISPMs and CPM Recommendations. Additionally, participants are encouraged to share successes and challenges with implementing the IPPC Strategic Framework (2020-2030) which is presented for adoption during CPM-15 (2020). A call<sup>1</sup> was issued on the IPP on the 8th of January 2020 requesting IPPC contracting parties, RPPOs and CPM observers to submit proposals.

3. Submissions should be no more than 1-2 pages in length, be prepared in one of FAO's official languages and must be submitted prior to the 28th of February 2020.

Cases will be selected using the following criteria: 4.

- Relation of the case proposed to the CPM and IPPC Secretariat's priority areas of work (e.g. Phytosanitary Capacity Evaluation conducted, activities related to recent pests outbreaks or e-Commerce);
- Clarity and conciseness of the case;
- Potential interest and usefulness to members of the IPPC community.

5. All cases meeting the above criteria will be compiled into a CPM document and due to time constraints, a maximum of five cases will be selected by the IPPC Secretariat (based on geographic representation and diversity of the issue) for which the submitter will be requested to prepare and give a 5 minute intervention during CPM-15 (2020).
