IPPC Roster of Experts: Nomination Form

Agenda item 10.2 of the Provisional Agenda

1. At its 6th session in April 2004, the ICPM agreed to the production of an experts roster system that can be used for relevant nominations for dispute-settlement.
2. The Subsidiary Body for Dispute Settlement (SBDS) had already started the development of forms for the nominations of experts for dispute settlement, and these were completed during 2004.
3. Generally, calls for nominations will be made when an IPPC dispute settlement process is initiated and they will be for targeted nominations in relation to specific disputes. Please note that the present paper does not constitute a call for nominations, and nominations are not encouraged at this stage.
4. However, if countries wish to nominate experts for dispute settlements in general at this time, they may do so.
5. The form in Annex 1 relates to general nominations, and not to targeted nominations in relation to specific disputes. A more detailed form has been developed and will be available when such cases arise.
6. The form in Annex 1 is presented to the ICPM for information.
