# COMMISSION ON PHYTOSANITARY MEASURES

<b>Implementation Review and Support System Surveys: Overview of Work and Next Steps</b>

1. As part of the implementation review and support system (IRSS) activities, the IPPC Secretariat conducted surveys between September 2011 and December 2012 on the implementation of the following four standards<sup>1</sup>:

- ISPM 4:1995 *Requirements for the establishment of pest free areas*
- ISPM 6:1997 *Guidelines for surveillance*
- ISPM 8:1998 *Determination of pest status in an area*
- ISPM 13:2001 *Guidelines for the notification of non-compliance and emergency action*

2. The surveys were used to gather information on implementation of the standards, including challenges and best practices. Each survey was sent to the contact points of all contracting parties as well as to the FAO regional plant protection officers and Regional Plant Protection Organizations. The issues and follow-up actions outlined in this paper were derived from the results detailed in reports on each of these surveys<sup>2</sup>.

3. The Secretariat expresses thanks to the contracting parties that responded to the surveys. This information is extremely valuable for identifying successes, challenges and opportunities for improving implementation of the IPPC and ultimately for preventing the introduction and spread of pests. In the brief period of the IRSS' work so far, these surveys have already proven useful to target capacity building and other work to address specific gaps that contracting parties have identified.

Additional surveys will be conducted in the future and the Secretariat encourages contracting parties to invest time into robust responses.

4. The IPPC Secretariat and the Capacity Development Committee (CDC) suggest future actions based on the conclusions from the survey results. Some of the issues and actions suggested for follow up on the analyses of ISPM 4:1995 (*Requirements for the establishment of pest free areas*), ISPM 6:1997 (*Guidelines for surveillance*), ISPM 8:1998 (*Determination of pest status in an area*) and ISPM 13 (*Guidelines for the notification of non-compliance and emergency action*) are summarized in Table 1. Issues relating to four of the ISPMs were cross cutting and are therefore presented together. The specific aspects of each of these issues are detailed in the specific reports of each survey.
