I. Introduction

1. At the Fifth Session of the Commission on Phytosanitary Measures (CPM-5, 2010), a Language Review Group (LRG) procedure to correct editorial errors in language versions of adopted ISPMs was adopted. The IPPC Secretariat (Secretariat) provides information on the establishment and process of LRG on the IPP https://www.ippc.int/index.php?id=1110770&no_cache=1.

II. Establishment of Language Review Groups

- 2. In 2012, no new language review groups were established.
- 3. The previously established LRGs for Chinese, French and Spanish reviewed the standards adopted at CPM-7 (2012).
- 4. The Coordinator of the LRG for Russian resigned after CPM-7 (2012) and so this group did not review standards adopted at CPM-7 (2012). A new Coordinator is needed in order to continue the review of adopted standards in Russian. Forty-three standards, diagnostic protocols and phytosanitary treatments are recommended for adoption in Russian at CPM-8 (2013) which will be subject to the LRG process.
- 5. Arabic members have not yet established a LRG.

III. Review of CPM-7 Adopted Standards

6. The Secretariat received the ISPMs adopted at CPM-7 (2012) with proposed modifications in track changes from the Chinese, French and Spanish LRGs. The Secretariat submitted these to FAO translation services, who reviewed the proposed changes and prepared comments on issues, disputed terms and disagreements raised during the revision work.

7. The Secretariat stresses the importance of respecting the deadlines set out in the CPM approved LRG procedure, asking that LRGs submit reviewed standards in time to allow time to process these standards for presentation to the following CPM session and thus to spread out the workload of the Secretariat.

IV. Chinese (details provided only in Chinese)

- 8. The LRG for Chinese did not review amendments to ISPM 5 Glossary of Phytosanitary Terms and Supplement 1 to ISPM 5, agreeing with the proposed translation adopted at CPM-7.
- 9. The FAO Chinese translation group agreed with all the proposed changes made by the LRG.

V. French

10. The FAO French translation group agreed with all the proposed changes made by the LRG.

VI. Spanish (details provided only in Spanish)

11. Details on translation issues considered and the outcome of these discussions on the ISPMs in Spanish are presented in the Spanish version of this paper.

VII. Recommendations

- 12. The CPM is invited to:
 - 1) *note* that ISPMs have been reviewed by the Chinese, French and Spanish LRGs and FAO translation services
 - 2) *note* that Russian speaking members need to choose a replacement for the Coordinator of the Russian LRG
 - 3) *urge* its members who participate in LRGs to ensure that the deadlines for the CPM adopted LRG process are followed and due dates respected
 - 4) request the Secretariat to accept all changes as indicated in track changes in the Attachments 1 to 17 and replace the Chinese, French and Spanish ISPMs adopted at CPM-7 (2012) with these modified versions.
