List of designated points of entry for plant health controlled plants, plant products and other regulated articles (2010)

## Introduction

In conformity with the Act No. 326/2004 Coll., the State Phytosanitary Administration of the Czech Republic (SPA) issues the list of points of entry in Czech Republic for compliance checking of imported consignments and other regulated articles. Compliance checking of imported consignments of plants, plant products and other regulated articles constitutes of a documentary check, a consignment integrity check, phytosanitary inspection, provided material is not prohibited entering the EU.

Plants, plant products and other regulated articles which have to undergo compliance checking at import are listed in Annex No. 9 of the Act No. 215/2008 Coll.

When importing these consignments every stakeholder has to be licenced by SPA. SPA licences them in accordance with Art.12 and 13 of the Act No. 326/2004 Coll. The consignees are obliged to submit consignment to import phytosanitary inspection and allow scope of execution in conformity with the law, otherwise they are prosecuted for infringement. This is not applicable for a small quantity of goods, intended for a private use or consumption during the transport, provided there is no risk of spreading pests from it.

Import of plants, plant products and other regulated articles undergoing compliance checking is allowed through specific points of entry only. Points of entry are ports for shipping, customs departments of border EU member states for land transportation and selected airports in EU for aerial transportation.

Compliance checking at import can be carried out in point of destination, provided the place has been previously authorized by SPA and Customs service. Importer can apply for authorization of such place in case it complies with minimum technical requirements for furniture and equipment required by Annex No. 18 of the Act 215/2008 Coll.
