Three Launch Sessions for new IPPC Technical Resources

Each session will take place in the Iran Room, Building B, 1st floor.

A series of technical resources is being developed to support national-level implementation of the IPPC. The IPPC Capacity Development Committee directed the Secretariat's development of these materials to achieve objectives set by the CPM-approved IPPC Capacity Development Strategy. The materials are intended to be globally relevant, and available to adapt to country and regional needs. The launch sessions will discuss opportunities for national and regional use of the materials, and opportunities for you to be involved in the next steps. Coffee and fruit will be served for participants 30 minutes before the start of each session.

1. NPPO Establishment Manual

Tuesday 17 March 2015, 13:30–14:30

A set of materials on establishing and operating NPPOs. The manual provides information on legal policy provisions for the establishment of an NPPO structure, mechanisms for financial resources, human resources, cooperation with third parties and enforcement.

2. Plant Pest and Disease Diagnostic Manual

A series of materials on Plant Pest Surveillance has been developed in cooperation with Plant Health and Environment Laboratory (PHEL), New Zealand, to support NPPOs to develop a plant pest diagnostic laboratory for plant pests and diseases.

3. Manual on Managing Relationships with Stakeholders.

This manual provides options on what kinds of stakeholder relations NPPOs can establish and how they can be maintained.
